## MASTER 1 - Droit international des affaires, parcours International Trade and Investment Law ASSOCIATED TO the University Diploma LL.M. in INTERNATIONAL BUSINESS LAW

### LYON TRACK



Two semesters in Lyon (from September to May). Successful students will be awarded an LL.M. in International Business Law (French Official Master 1 degree).

OR

### MAYNOOTH TRACK



One semester in Lyon (from September to December) and one semester in Ireland, at Maynooth University (from January to May). This track is jointly provided by UCLy and Maynooth University (Ireland). Successful students will be awarded an LL.M. in International Business Law (French official Master 1 degree) and a Master of Laws (LL.M.) by Maynooth University.

## MASTER 2 - Droit international des affaires, parcours International Trade and Investment Law ASSOCIATED TO the University Diploma LL.M. in EUROPEAN and INTERNATIONAL TRADE and INVESTMENT LAW

### LYON TRACK



Two semesters in Lyon (from September to May). Successful students will be awarded an LL.M. in European and International Trade and Investment Law (French Official Master 2 degree).

OR

### ST JOHN'S TRACK



One semester in Lyon (from September to December) and one semester at St John's University in New York (from January to May). At the end of both semesters, successful students will be awarded an LL.M. in European and International Trade and Investment law (French official Master 2 degree) and a Master

### NEW YORK BAR PATHWAY

Students choosing the St John's Track have the opportunity to prepare for the New York Bar exam (check the requirements). Students may decide to stay for another semester at St John's University to prepare for the New York Bar exam after having successfully completed the St John's Track. Dual LL.M. students would have to enroll in at least 12 credits during the autumn semester at St John's University. St John's University would charge a preferential rate for the second semester of coursework.

## M1 ADMISSION REQUIREMENTS

### Entry requirements

Applicants are required to have an undergraduate degree in law (a French Law degree, an LL.B. or equivalent). The Admission Committee will examine background and relevant professional experience if any on a case-by-case basis. The Admission Committee will consider applications based on international diplomas on a case-per-case basis.

### English language requirements:

International students should have the appropriate level of English proficiency with a minimum IELTS Score of 6.5, a minimum TOEFL IBT score of 90, a CAE score of 58 or a DUOLINGO (internet based accepted) score of 120. The Admission Committee may consider any experience establishing the command of the English Language (native). For the Lyon Track, the IELTS online is accepted.

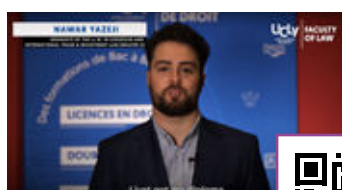

## M2 ADMISSION REQUIREMENTS

### Entry requirements

Applicants are required to have an undergraduate degree in law (a French Licence, a LL.B. or equivalent) and a Postgraduate degree and in any event at least 4 years of undergraduate studies. Acceptance of applicants with other types of diplomas will be determined by the Admission Committee which may also take into account relevant professional experience.

### English language requirements:

International students should have the appropriate level of English proficiency. Students should have a minimum IELTS Score of 6.5, a minimum TOEFL IBT score of 90, a CAE score of 58 or a DUOLINGO (internet based accepted) score of 120. The Admission Committee may consider any experience establishing the command of the English Language. For the Lyon Track, the IELTS online will be accepted. Official language test is mandatory for St John's Track and NY Bar Track applicants except for natives of Canada, UK, Ireland, New-Zealand and Australia.
