# Online University Diploma - LL.M. Digital Law and Technology



A diploma, taught remotely, full-time or à la carte for continuous education

This program is open to graduates who wish to gain a deep understanding of the European legal framework brought in to deal with the issues and challenges of the digital transformation of our economy and society. Students will study four key topics among the six proposed modules: privacy and data protection, intellectual property, contract law, cybercrime and cybersecurity, regulation of the internet applied to the digital economy and artificial intelligence (its ethics and regulation).

## **KEY OBJECTIVES**

- E-privacy: understanding the issues and mastering the principles governing privacy and data protection
- Intellectual property: Mastering the principles of IP and the impact technological innovations have had on these principles
- Contract law and the digital economy: understanding issues specific to contracts concluded over the internet and studying special contracts that have digital products or services as their subject matter
- Artificial Intelligence: understanding the ethics of AI and exploring how the EU is proposing to regulate innovation
- Cybercrime and cybersecurity: understanding the key risks linked to illegal activities online and through digital medias
- Regulation of the internet: understanding the new EU legislation on the regulation of online content and the regulation of platforms
