

"Student" residence permit's renewal

List of supporting documents:

- ✓ Identity document. You have:
 - O <u>A residence card:</u> Front and back of your valid residence permit
 - A long stay visa:
 - Page of your passport relating to civil status
 - Page with the "student" visa
 - Page with the entry stamp in France
- Recent e-photo: Indicate the e-photo number mentioned on the photo sheet.

 Caution: you must select the format: "E-photo for a driving license". No PDF, JPEG etc.
 - ✓ Proof of address less than 6 months old:
- O <u>You live in a CROUS/student residence (St Bernard, St Laurent houses, CROUS residence, private student residence):</u>
 - Certificate of residence
 - O You are a tenant or home-owner:
 - Water or electricity or gas or fixed or cell phone or internet bill mentioning your name
 - $\underline{\text{Or}}$ lease agreement (only from an authorized body documents between individuals are not accepted)
 - Or last receipt of rent (only from an authorized body- documents between individuals are not accepted)
 - Or certificate of home insurance
 - You live in a hotel:
 - Certificate from the hotel manager
 - Or last month's invoice



- You are staying with a private individual (family, friend...)
- Dated and signed certificate of accommodation from your host. See PDF "(Modèle) Attestation d'hébergement FR-EN".
- His/her identity card (if your host is French/European) or valid residence permit
- Proof of residence in his/her name (if the address on his/her identity card is no longer up to date)
- ✓ Scholarship certificate or proof of pre-enrolment at the UCLy

Caution: If you upload a certificate of enrollment/pre-inscription, note that you will mandatory have to provide a scholarship certificate to obtain the validation of your renewal application.

<u>If your study at UCLy includes a European mobility</u>: you must also provide a document produced by your faculty/school/institute justifying this European mobility.

- ✓ Transcript of grades: please attach all of your transcripts for the period of time since obtaining your last visa/residence permit
 - ✓ Last diploma obtained in France (if concerned)
 - ✓ Certificate of achievement (if your faculty/school/institute provides one)
 - √ Financial resources:

Caution: monthly statements of account are not a valid

The amount of your financial resources must be equivalent to 615€/month

- O You receive money from a parent/ another person:
- Bank certificate from this person proving the planned regular transfers to your account for an amount of minimum 615€/month
- Or Certificate on the honor of payment of the sums required to reach the amount of minimum 615€/month. See PDF "[Modèle] Attestation de prise en charge FR-EN"
- Proof of identity of the third party
 - You are an employee:
- Pay slips of the last 3 months
 - You have your own savings:
- Bank certificate of sufficient credit balance. The amount has to be minimum 6.150€ for a year.



O You have a scholarship:

- From you home country: please provide a certificate of scholarship from the paying agency of the home country specifying the amount and duration of the scholarship.
- From the French government scholarship holders and beneficiaries of European programs: please provide the scholarship certificate.
