

“Student” residence permit’s renewal

The application for the “Student” residence permit renewal has to be submitted 4 to 2 months before the expiration date of your visa/residence card.

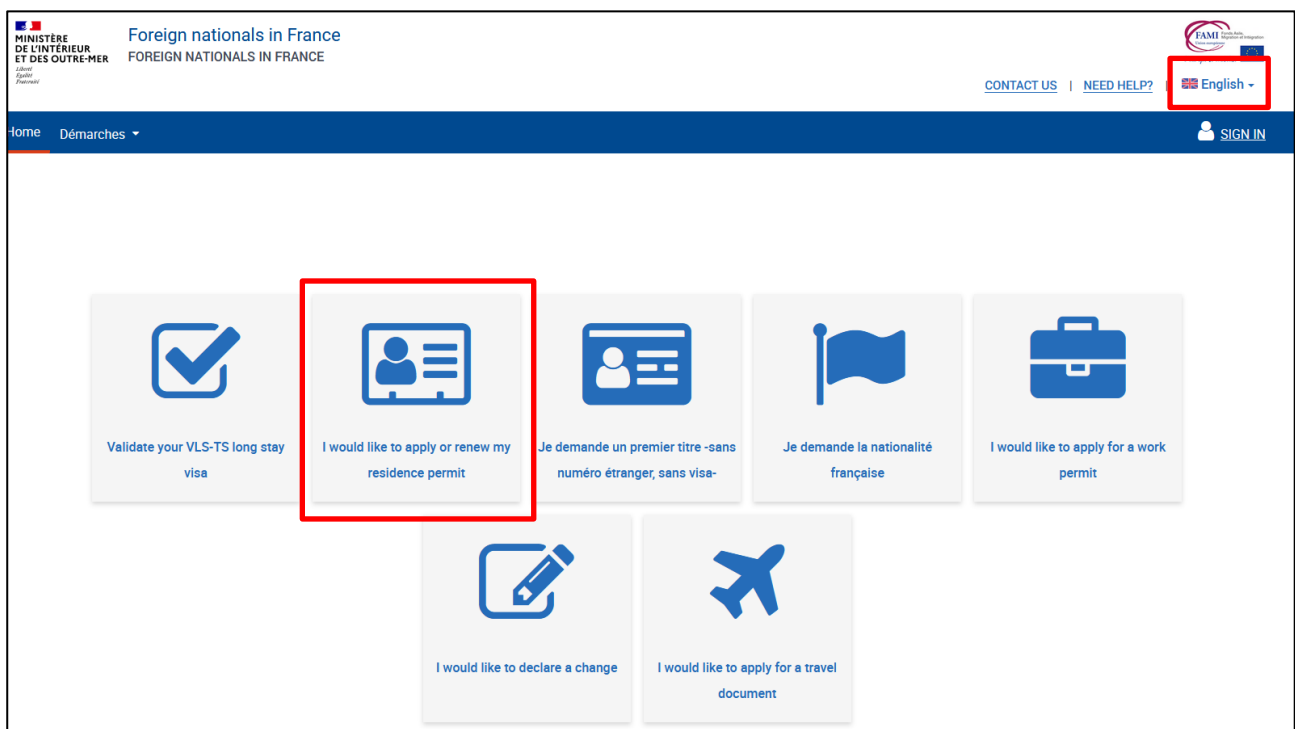
Example:

Date of expiration: 18th August

Renewal to do between the 18th May and 18th June.

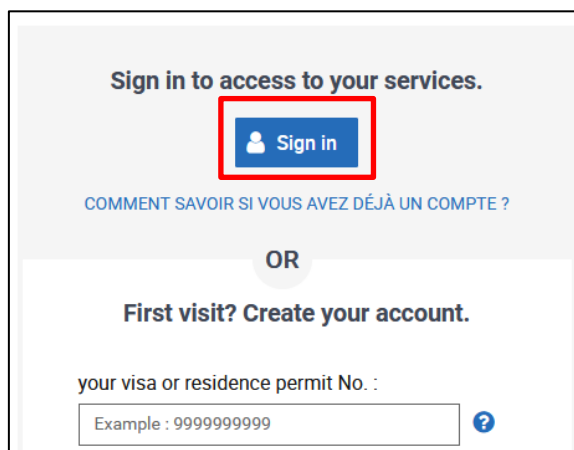

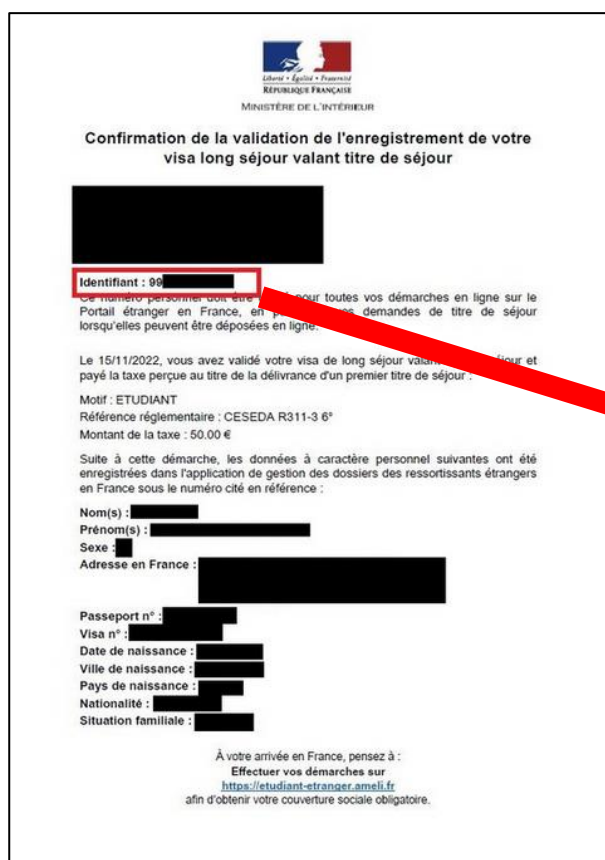

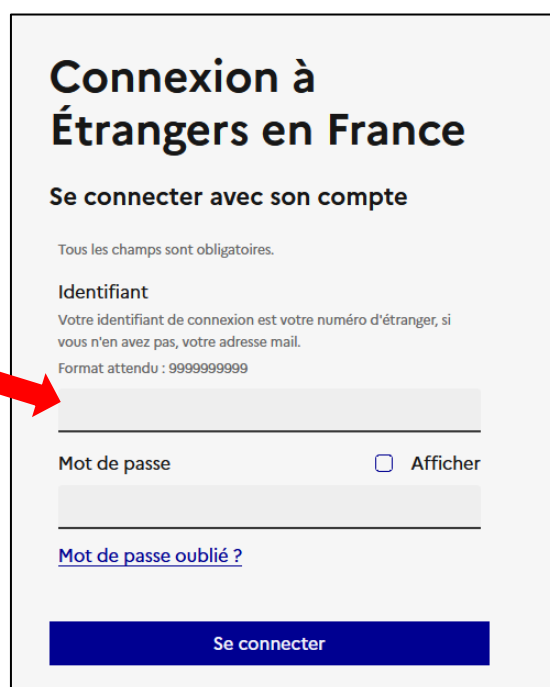

Step 2: Purpose of stay

You are holding a “Student” visa/residence card that you want to renew.
Then, you will have to fill the information concerning the **ongoing** academic year and the **next** coming one.

Caution: your “Student” visa/residence card will be refused if:

- You didn't study during the time of your visa/residence card / You missed to many classes / You don't progress
- You are not enrolled in a university next year
- You don't have sufficient financial resources to live in France

Caution: You will have to provide a mobility certificate from your faculty [ESDES, Law] mentioning the **country** and **dates of mobility**. You can obtain a residence permit “Student – Mobility Program” allowing to stay more than 90 days in another EU-country, without having to apply for the visa.



Step 3: Financial resources

The total amount of your resources must be at least equal to 615€/month

- *Salarié*: you have a student job / alternance
- *Boursier*: you have a scholarship
- *Pris en charge*: you receive money from another person (parent, family member, sponsor etc.)
- *Ressources personnelles*: you have your own savings on your personal bank account

You can select several origins of resources to add incomes. For example: *Salarié* [200€] and *Pris en charge* [450€]

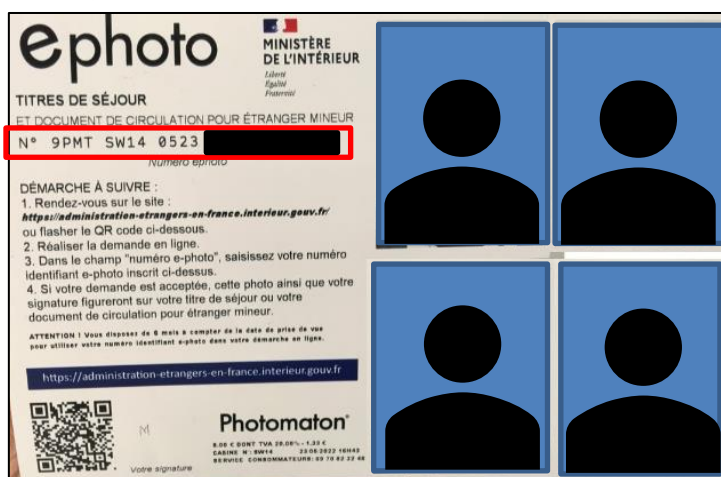

✓ **Proof of address less than 6 months old*:**

*The document must have been dated/signed less than 6 months ago.

○ *You live in a CROUS/student residence* [CROUS, St Bernard, St Laurent houses, private residence]:

2) Purpose of stay

School certificate: final enrolment after paying all tuition fees

Certificate of pre-enrolment: given after payment of a small amount of tuition fees [acompte]

Caution: If you upload a *certificate of pre-enrollment*, note that the Prefecture will ask you to mandatory provide a *school certificate* at the semester start.

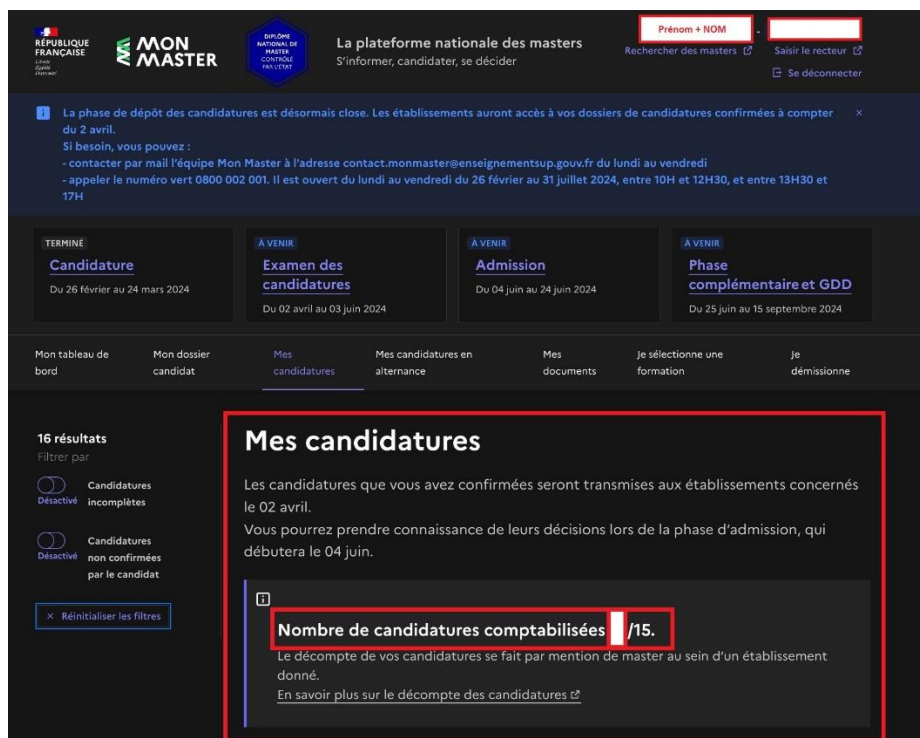
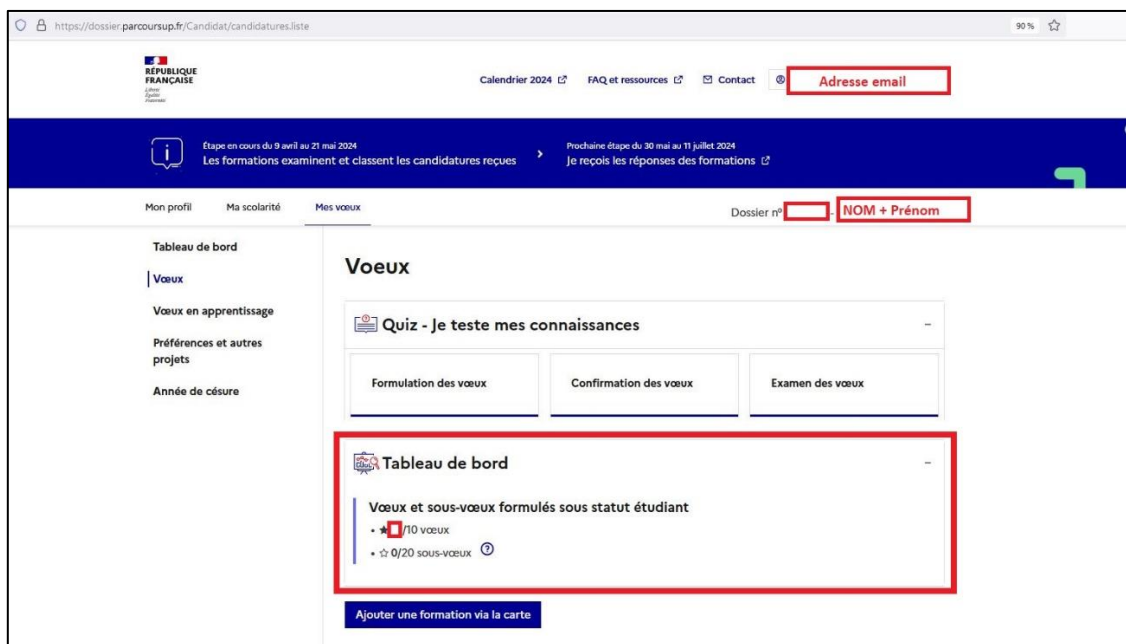
**If your study includes a European mobility [exchange/internship]:* document from your faculty [ESDES/Law etc.] mentioning the country and dates of mobility. Upload this document with the school certificate/pre-enrolment.

**MSc student [ESDES]:* Letter from ESDES indicating the date of graduation jury.



*You are finishing your study [Master 2]: Letter from your faculty [Law, ESDES etc.] indicating the date of graduation jury.

*If you are awaiting results on Parcoursup / MonMaster: screenshot of your applications. **You name must be visible on the screenshot.**



Ongoing academic year

- ✓ **Transcript of grades/records:** transcripts of grades since you obtained your visa/residence permit.
**If you don't have all grades for the ongoing year (ongoing semester for example):* detained transcripts + current school certificate.
- ✓ **Last diploma obtained in France** [if concerned]
**ILCF student:* you can provide your *Diplôme Universitaire d'Études Françaises* (DUEF).
- ✓ **Certificate of achievement** [optional]: UCLy doesn't provide this document since you have transcripts of grades/diploma.

3) Financial resources:

Caution: monthly statements of account are not a valid
The amount of your financial resources must be equivalent to 615€/month

- ✓ **"Pris en charge" = You receive money from a parent/ another person:**
 - Bank certificate of this person proving regular transfers to your account for next academic year;
 - Or Certificate on honor completed, dated and signed by this person. See PDF "[Example] Financial responsibility_FR-ENG"
 - Passport/ID card of this person.
- ✓ **"Salarié" = You have a student job or you are an intern/alternant**
 - Pay slips of the last 3 months
**If your working contract has started less than 3 months ago:* detained pay slips + contract [all pages].
- ✓ **"Ressources personnelles" = You have your own savings:**
 - Bank certificate of credit balance [if your account is abroad, amount must be expressed in €].
For 1 academic year, your balance must reach at least 6.150€.
- ✓ **"Boursier" = You have a scholarship:**
 - From you home country: certificate of scholarship/grant mentioning the amount and duration of the scholarship.
 - From the French government or a European program: certificate of scholarship/grant mentioning the amount and duration of the scholarship.

Step 5: Summary

Read carefully the provided information.

In the *Comments for the administration* section, you can add details about your application. For example, “awaiting admission on Parcoursup/MonMaster / awaiting 2nd semester grades”.

Caution: Once you click on “Validate and submit my application”, you will no longer be able to add documents or to modify your application.

Step 6: Confirmation

You will automatically receive an acknowledgement of receipt of your application by e-mail, along with a PDF *Confirmation of submission* [*Confirmation de dépôt*].

This document is proof that your application has been submitted. It is not a *récépissé*, extension or residence permit.

What happens next?

Your visa expires:

At the latest the day of expiration, you will receive a Visa Extension *Attestation de Prolongation* [notification per email, document on your account].

This document extends your “Student” visa, so allows you to:

- Travel [leave and come back France]
- Work part-time

This document is only valid with the detaining visa, even expired.

Don't forget to send it to the CAF!

As long as your application is still ongoing, you will receive extensions [at the latest the day of expiration].

Your application was incomplete [missing school certificate 2025-26 / grades for the 2nd semester]:

The Préfecture will ask you for these documents while checking your application.

You will have 30 days to upload all asked documents.

The Prefecture accepts your renewal:



You will receive an *Attestation de Décision Favorable* (notification per email, document on your account).

4 to 6 weeks after, you will receive a text on your phone indicating that your card is available.

You will have to:

- Buy a 75€ tax stamp (or 255€ if late)
- Book an appointment at the Prefecture to get your card

Don't forget to send the *Attestation de Décision Favorable* / back and front of your residence card to the CAF!
