*The translation is not needed for following countries: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Hungary, Iceland, Ireland, Italia, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal (archipelagos of Madeira and the Azores), Romania, Slovakia, Slovenia, Spain (Balearic and Canary Islands), Sweden, UK.
